

Agreed Minutes

Delegations representing the Aeronautical Authorities of the Kingdom of Saudi Arabia and the Dominican Republic met in Riyadh, Kingdom of Saudi Arabia, on December 5, 2023 to discuss matters related to the air services arrangements between both countries.

The meeting was held in a friendly and cordial atmosphere. The delegation lists are attached as Attachment A.


Both Delegations agreed that the exercising of 7th freedom traffic right for only cargo operations by the designated airlines of each Party is subject to mutual agreement between the Aeronautical Authorities of both Parties.

This Agreed Minutes is an integral part of the MOU signed in Aqaba, the Hashemite Kingdom of Jordan on 4 December 2019 and shall come into effect on the date of its signature.
