# AGREED MINUTES BETWEEN THE AERONAUTICAL AUTHORITIES OF THE GOVERNMENT OF THE DOMINICAN REPUBLIC AND THE GOVERNMENT OF THE REPUBLIC OF SURINAME

Delegations representing the Aeronautical Authorities of the Dominican Republic and the Republic of Suriname hereinafter referred to as "The Delegations" met on the 6<sup>th</sup> of December 2023 during ICAN 2023 event that took place in Riyadh, Kingdom of Saudi Arabia, to discuss civil aviation matters of mutual interest between the two countries.

The composition of the Delegations is attached as Appendix (1).

The discussions were held in a cordial and friendly atmosphere. Both Delegations expressed their desire to further promote their aeronautical relations in a spirit of cooperation and complete understanding for their mutual benefits.

#### THE FOLLOWING ISSUES WERE AGREED UPON:

#### 1. TEXT OF THE AIR SERVICES AGREEMENT (ASA):

- 1.1 Both Delegations reached an agreement on the proposed amendments made by the Delegations.
- 1.2 The Heads of the two Delegations initialed the Air Services Agreement (referred to as ASA hereinafter) on this day stated below in the English language (Appendix 2)
- 1.3 Both Delegations agreed to prepare their respective ASA versions in the Spanish, English and Dutch languages and to recommend to their respective Governments to sign the ASA at ICAN 2024. Place and date of the signing ceremony will be determined through diplomatic channels.
