MEMORANDUM OF UNDERSTANDING BETWEEN THE GOVERNMENT OF THE DOMINICAN REPUBLIC AND THE GOVERNMENT OF THE STATE OF QATAR

Representatives of the Government of the Dominican Republic and the Government of the State of Qatar, the members of which appear in the list attached as (Appendix I), have met in Montreal, Canada, the 27th of September 2022, to discuss matters related to air services between the Government of the Dominican Republic and the Government of the State of Qatar for Air Services.

The negotiations were held in a cordial and friendly atmosphere and both delegations expressed their wish to strengthen their air services relations and enhance the commercial opportunities for the designated airlines and decided to sign a Memorandum of Understanding between the Government of the Dominican Republic and the Government of the State of Qatar.

Both Parties agreed on the following:

1. Seventh Freedom for All Cargo Services

The designated airlines of each Contracting Party shall be entitled to exercise full Seventh freedom traffic rights for all cargo flights without any restrictions.

2. Effect of the Memorandum of Understanding

Both delegations have agreed that this Memorandum of Understanding complements the previous Memorandum of Understanding signed on 17th December 2012 between the Government of the Dominican Republic and the Government of the State of Qatar and shall come into effect on the date of its signature.
