AGREED MINUTES

The delegations representing the aeronautical authorities of the Dominican Republic and the Republic of Hungary met in Santo Domingo, on 6-7 March 2003, with the purpose to discuss a bilateral Air Services Agreement (ASA) to be concluded between their countries. At the same occasion, the authorities discussed practical operating possibilities for airlines from both sides. A list of the delegations is at Attachment 1 of this Agreed Minutes.

The meeting was held in a spirit of great cordiality and understanding.

The delegations reached the following understandings:

The two delegations discussed, and reached agreement on the text of the ASA (Attachment 2). Each delegation undertook to do their utmost in order to prepare the ASA for signing, in accordance with their respective domestic legislation, within the shortest time possible. The Hungarian delegation invited the delegation of the Dominican Republic to Hungary for the signing of the ASA.

The Hungarian delegation confirmed its intention to designate MALÉV Hungarian Airlines to operate routes pursuant to the Annex of the ASA.

The delegation of the Dominican Republic gave the information that its airline/airlines to operate routes pursuant to the Annex of the ASA will be designated later on.

The two delegations agreed that the designated airlines will enjoy the same rights under the ASA.

The two delegations agreed, in a practical approach, to apply the provisions of the ASA on a provisional basis as of the date of signature of this Agreed Minutes in order to allow the further development of air services between the two countries by their respective airlines.

The two delegations undertook to give their relevant authorizations to any applications by designated airlines to operate agreed services on the routes provided for in the Route Schedule in the Annex of the ASA as of the date of the signature of this Memorandum.

The delegation of the Dominican Republic confirmed to grant their relevant authorizations to MALÉV Hungarian Airlines to place its "MA" designator code on authorised scheduled flights operated by Air Europe (UX) between Santo Domingo and Madrid. This operation of MALÉV would only include transportation of passengers between Santo Domingo and Budapest and the "MA" designator code would appear only in conjunction with flights between Santo Domingo and Budapest. No fifth freedom right would be exercised by MALÉV. The authorizations will be issued to enable MALÉV to begin this operation commencing on 1 May, 2003 with services for sale in Computer Reservation Systems (CRS) effective on 1 April, 2003.

This Agreed Minutes takes effect on signature.
