

**AGREED MINUTES
BETWEEN THE AERONAUTICAL AUTHORITIES OF
THE HASHEMITE KINGDOM OF JORDAN
&
THE DOMINICAN REPUBLIC**

Delegations representing the Aeronautical Authorities of the Hashemite kingdom of Jordan and the Dominican Republic hereinafter referred to as "The Parties" met on the 5th of December 2023 during ICAN 2023 event that took place in Riyadh, Saudi Arabia, to discuss civil aviation matters of mutual interest between the two countries.

The composition of the Delegations is attached as **Appendix (1)**.

The discussions were held in a cordial and friendly atmosphere. Both Parties expressed their desire to further promote their aeronautical relations in a spirit of cooperation and complete understanding for their mutual benefits.

THE FOLLOWING ISSUES WERE AGREED UPON: -

1. TEXT OF THE AIR SERVICES AGREEMENT (ASA):

1.1 Both Parties reached an agreement on the proposed amendments made by the Parties.

1.2 The Heads of the two Delegations initialed the Air Services Agreement (referred to as ASA hereinafter) on this day stated below in the English language (Appendix 2)

1.3 Both Parties agreed to prepare their respective ASA versions in the Arabic, Spanish, and English languages and to recommend to their respective Governments to sign the ASA at ICAN 2024. Place and date of the signing ceremony will be determined through diplomatic channels.

2. CHARTER SERVICES:

Both Parties agreed that the Airlines of both Parties may operate charter flights between the Territories of their respective countries provided that such services fully comply with the rules and regulations enforced by each Party.
