

## **Memorandum of Understanding**

The Delegations representing the Aeronautical Authorities of the Government of the Hashemite Kingdom of Jordan and the Government of the Dominican Republic whose names appear in attachment "A" met in the fourth ICAO Air Services Negotiation Conference (ICAN 2011) held in Mumbai, India, from 17-22 October 2011 to discuss matters relating Air Services Agreement between the two countries. As a result of these discussions, which were held in a very cordial and friendly atmosphere, the following understandings have been reached:

### **Substantial ownership**

During the discussions the Dominican Republic expressed its willingness to accept the original proposal of the Hashemite Kingdom of Jordan to keep the term substantial ownership from Articles 3 and 4 of the ASA.

### **Entry Into Force**

Both Delegations agreed that this MOU is an amendment to paragraph 3 of Article 1 of the October 1, 2009 MOU and that it will enter into force from the date of its signature.
