MEMORANDUM OF UNDERSTANDING BETWEEN THE CIVIL AVIATION AUTHORITIES OF THE DOMINICAN REPUBLIC AND THE REPUBLIC OF POLAND

Representatives of Civil Aviation Authorities of the Dominican Republic and the Republic of Poland, the members of which appear in the list attached as Appendix I, have met in Riyadh, Kingdom of Saudi Arabia on 6 December 2023 in the margins of ICAO Air Services Negotiation Event (ICAN 2023) to discuss matters related to air transport between the Government of the Dominican Republic and the Government of the Republic of Poland.

The meeting was held in a cordial and friendly atmosphere and both Delegations expressed their wish to strengthen their air transport relations, enhance the commercial opportunities for the airlines and decided as follows:

I. Non-scheduled flights

Both Delegations agreed that the eligible airlines of the Republic of Poland (an airline or airlines licensed to perform commercial air carriage in accordance with the European Union law) and the airlines of the Dominican Republic may operate non-scheduled flights between their respective territories, provided that such services fully comply with the laws and regulations enforced by each State.

- In order to stimulate growth and development of tourism and trade between the two countries, the eligible airlines of the Republic of Poland and the airlines from the Dominican Republic will receive the relevant authorization to operate non- scheduled flights for passengers (and their baggage), cargo or combined, subject to the national laws and regulations enforced by each State.
- 2. Each side, under conditions of reciprocity shall respond, within the terms established by their respective authorities and without delay, to requests for non-scheduled flights made by the airlines of the other side.

II. Effect of the Memorandum of Understanding

This Memorandum of Understanding will enter into force as of its signature and will be applied meanwhile the Air Services Agreement between the Dominican Republic and the Republic of Poland is in force. This Memorandum of Understanding complements the Memorandum of Understanding signed on December 4, 2019.
