## Record of Discussion between the Delegations of The Republic of Rwanda and the Dominican Republic

Delegations representing the aeronautical authorities of the Republic of Rwanda and the Dominican Republic (hereinafter referred to as "delegations") met in Bogotá, Colombia, on 7 December 2021 within the framework of the ICAO Air Services Negotiation Event ('ICAN2021') to discuss current bilateral relations in the field of civil aviation between both countries.

The list of members of both delegations is attached as Appendix.

The discussions were held in a cordial and friendly atmosphere. Both delegations expressed their desire to promote their aeronautical relations in a spirit of cooperation and complete understanding for their mutual benefits.

The delegation of the Dominican Republic proposed a protocol to amend the Air Services Agreement between the Republic of Rwanda and the Dominican Republic (hereinafter referred to as "ASA") signed on December, 4 2019 in Aqaba, Hashemite Kingdom of Jordan to modify the provision of sub-paragraph j) Article 1 of ASA (definition of territory) because of Dominican internal Constitutional requirements and in accordance with the Model Air Service Agreement of the International Civil Aviation Organization (ICAO).

The delegation of the Republic of Rwanda accepted the proposed changes and suggested that the Dominican Republic signs the **Protocol that amends the Air Service Agreement between the Republic of Rwanda and the Dominican Republic for Rwanda** to countersign it at a later date, and return it to the Dominican Republic through diplomatic channels. The delegation of the Republic of Rwanda received 2 copies of the ASA in both English and Spanish.
