

**AGREED MINUTES OF MEETING
BETWEEN
GOVERNMENT OF MALAYSIA AND THE DOMINICAN REPUBLIC**

1. On the occasion of the 17th ICAO Air Services Negotiations Conference 2025 (ICAN 2025), delegations representing the Aeronautical Authorities of the Government of Malaysia and the Dominican Republic met on 13th November 2025 to continue discussing the establishment of new Air Services Agreement (ASA).
2. The discussions were held in a cordial atmosphere reflecting the friendly relations between the two countries.
3. The composition of the delegations is attached as **Appendix A**.
4. Both delegations discussed and deliberated the draft text of the Air Services Agreement (ASA) and have principally agreed to the draft text of ASA except for Article 14 – Taxation. Both delegations agreed to undertake further domestic consultation with regards to the formulation of that article.
5. The draft ASA is attached as **Appendix B**.
6. Both delegations agreed that the text shall be subjected to further internal consultations and approval from both countries, and to notify each other on the outcome through correspondence.
